

DOCUMENTS REQUIRED FOR REGISTRATION TO ASSOCIATE DEGREE AND UNDERGRADUATE PROGRAMS

Registration Documents:

- a) **Diploma:** Original of Secondary Education (High School) diploma and its Turkish translation approved by the Turkish Embassy, Consulate or Notary.
- b) **Original of Transcript** (Grade Statement) and its Turkish translation approved by the Turkish Embassy, Consulate or Notary
- c) **Diploma Equivalence Certificate:** Document obtained from the Turkish Ministry of National Education or Turkish Embassies or Consulates in their country, showing that the High School Diploma is equivalent to diplomas received from Turkish High Schools.
- ç) **Exam Result Certificate:** Original of the exam result certificate (KÜNYÖS, SAT, TR-YÖS) used for the application.
- d) **Passport:** Notarized copy of the passport with at least 6 months validity, showing the nationality of the international student.
- e) (Candidates with dual citizenship, one of which is Turkish, or Turkish nationals who received their entire high school education through formal education from high schools abroad (excluding TRNC high schools) must bring a clear, readable photocopy of the passport or e-government/police records from the passport pages showing the duration of the education and training in the country where the diploma was obtained, and showing that the **entry and exit were made**, or a certified document obtained from the Police Department.)
- f) 2 biometric **photographs** of 4.5 x 6,
- g) **TÖMER Certificate:** A result document showing Turkish proficiency or at least B1 level.
- ğ) **Blue Card:** A photocopy of the Blue Card of students who hold a Blue Card documenting this status.
- h) A photocopy of the protection cards of students who were accepted with an **International Temporary Protection Card**.
- ı) **Certificate of Population Registration:** A copy of the citizenship acquired while being a foreign national and later on, and a copy of the Turkish Republic. a copy of the population registration certificate valid as of the date of final registration, showing that the dual citizenship of those who have become citizens / dual nationals in this situation continues.
- i) **Financial Status Document:** This document showing that the student has provided the resources to cover his/her own living expenses.
- j) According to the "Cooperation Protocol on Residence Permit Applications of International Students" signed between the Council of Higher Education and the Ministry of Interior Immigration Administration on November 15, 2023, for the updating of visa and residence permit procedures and processes of international students;
 - Border gate entry stamp page on the passport,
 - **Visa label on the passport** (except those within the scope of visa exemption),
 - If any; residence permit document, stateless person permit document, international protection application/status document, temporary protection identity document, work permit document,
 - Work permit exemption document, blue card, foreign representative office personnel/family member identity card, must be declared to the registration officer.
